EASTSIDE WATER DISTRICT HAPPENINGS NOVEMBER 2023

FROM THE GENERAL MANAGER

- At the November 16, 2023 board meeting we continued to discuss our Surface Water Supply Usage- landowners with connection are encouraged to utilize this supply whenever available. If you receive a bill from TID for Replenishment water used in 2023 please submit the invoice to EWD for reimbursement. The cost of the water is covered by Eastside Water District.  - TID took their last water order on October 28th and stopped deliveries on November 1st.
 - o Bills for TID went out in mid-November and are due at the end of December.
 - o 3,938-acre feet in Replenish Water from Turlock Irrigation District Year-To-Date
 - o and 583-acre feet from Merced Irrigation District (MID) through October.
- Board Member, Todd Turley reported on the San Joquin Valley ACWA Forum and Tour he attended in September. His presentation included several recharge projects that were toured in Western Fresno County.
- Other Key Topics involved the ETS GSA-
 - Multi Benefit Land Repurposing Grant the agreement with the Department of Conservation has been signed. The next step is working with the partners to develop the plan.
 - Proposition 218 and Groundwater Pumping Fee Updates the consultants continue to receive input and work on the budget and Proposition 218 and Groundwater Pumping Fees. A public workshop is scheduled for December 14, 9:30 a.m. 11:30 a.m. to present the proposed assessment for ETSGSA.
