FROM THE GENERAL MANAGER

At the December 19, 2024, board meeting we reported on the following topics:

- ▲ Landowner TID Replenishment Water Use finished the season using 5,813-acre ft.
- ▲ ft. Merced Irrigation District is working with the landowners to improve the delivery of water.
- ▲ The Monte Vista Recharge Project at Monte Vista and Hall Road between Sand Creek and the Highline Canal. The EWD acquired the property for a Pilot Recharge Project to demonstrate various recharge opportunities growers may be able to utilize on their own farms. A new side gate will be installed this winter.
- ▲ The General Manager continues to meet with landowners to better understand the opportunities for projects. As more information is gathered further development and prioritization will occur in conjunction with ETSGSA, TID and landowners.
- ▲ Other Key Topics involving the ETS GSA-
 - GSA Proposition 218 Proposed Fee Structure for 2025-2032 The General Manager shared a map showing one of the projects that the proposed 218 Fees will pay for. It includes a pipeline for the distribution of surface water to more landowners that do not have access to canals. Then the landowner would be able to have a pond with the surface water for recharge and irrigation. EWD will have another in-depth discussion at their January 16, 2025 Board Meeting. Please come. The board wants your feedback on the 218 Fee Structure.
