<u>Item 4</u> East Turlock Subbasin Groundwater Sustainability Agency Update

Sarah Woolf, General Manager reported on the December 18 workshop. Ms. Woolf stated it was well attended, and there were a lot of questions and landowners expressed their concerns on the fee structure and options. There was also discussion about Projects and Replenishment Water. Sarah Woolf, General Manager, reported on a joint meeting with EWD, ETS GSA, and TID staff to discuss existing and potential replenishment projects. Ms. Woolf shared a map at the meeting that indicated where existing and potential replenishment projects were and could be to benefit landowners. There was also discuss about the need for additional outreach. **This item was for information only.**

<u>Item 5</u> Projects

- a. Replenishment Water The total use of TID replenishment water used by landowners for the season was 5,813 acre-feet.
- b. Merced Irrigation Water Delivery The total use of MID water for the season was 1,790 acre-feet. The General Manager had a good meeting with Hicham ElTal, MID, about making infrastructure improvements so more water can be taken at Dry Creek.
- c. Monte Vista Recharge Project Update The General Manager is meeting with the installer this afternoon to discuss the plans for the side-gate. TID has side-gate equipment on hold for EWD. Ms. Woolf will also be meeting today with a contractor that will remove the fence <u>and</u> repair the two existing gates. These items were for information only.
