FROM THE GENERAL MANAGER


At the May 22, 2025, meeting we a discussed:

- Proposed Projects:
 - Replenishment Water is available. TID is continuing to evaluate flows to determine the ability to deliver Replenishment water after June. Use the water now while it is available. Landowner Replenishment Water Use to date is **800-acre ft**.
 - ✓ Work has begun on designing of a Pipeline to deliver Turlock Irrigation District (TID) Replenishment Water to Sand Creek and Mustang Creek from the Main Canal
 - ✓ The Monte Vista Recharge Project at Monte Vista and Hall Road between Sand Creek and the Highline Canal is taking water. The pond is recharging well so far! [See the photos at the bottom of page 2.]
- Merced Irrigation District
 - ✓ Three gaging stations are being installed to evaluate recharge at Dry Creek.
- Other Key Topics involving the ETS GSA-
 - ✓ The EWD appointed a new board member, Sarah Woolf, and alternate, Jeanne Zolezzi, to represent them.
 - ✓ The Groundwater Use Fee is forthcoming in June. There will be workshops and open office hours provided for landowners to work with staff on their Groundwater Use and Fees in June and July.
 - ✓ The 2 Priority Action Areas maps are available to be viewed on the Turlock Subbasin Website; www.Turlockgroundwater.org
 - ✓ Phase 2 preparation of the Rules and Regulations for Groundwater Use continue to be discussed.
 - ✓ **Stay informed!** The board members **encouraged** landowners in Eastside Water District to attend the ETS GSA board meetings regularly and provide input.

- This year is the <u>final</u> Capital Charge for Irrigated Lands and <u>the end</u> of the Prop 218 Water Charges for Eastside Water District. The \$2 per–acre fee <u>will</u> <u>remain</u>.
 - Irrigated Lands: \$40.32 Per-Acre final Capital Charge, the \$10.67 Per-Acre final Maintenance charge, the \$5.34 Per-Acre final Groundwater Sustainability Agency charge, and the \$2.00 Per-Acre General fund charge on your 2025-2026 tax bill.
- Non-Irrigated Lands: \$5.34 Per-Acre final Groundwater Sustainability Agency charge. The \$2.00 Per-Acre General Fund charge on your 2025-2026 tax bill will remain.

In 2026-2027 you will be assessed by the East Turlock Subbasin (ETS) GSA fees for Irrigated and Non-Irrigated lands.

REPLENISHMENT WATER <u>AND</u> INFRASTRUCTURE REIMBURSEMENT PROJECT

Eastside Water District has a Replenishment Water Project along the Highline Canal.

The District helps with infrastructure costs and the cost of the water. Replenishment Water is available NOW!
